2. Urban Waters Cohort & PDE Summit Update (11:05-11:20)

- January 30-February 1 at Harrah's in Atlantic City NJ
- On **Monday, January 30**th of the Summit we will have the cohort session AS WELL AS a 1 hour Urban Waters partners session in the afternoon.
- Themes: lack of health and safety and quality of life in overburdened communities through Urban Waters. The value of revitalizing urban land in carbon sequestration, stormwater management, etc. Broadening our definitions of environmental justice. The importance of community planning.

- EJScreen Map of Priority Areas: Use the Supplemental Demographic Index under Socioeconomic Indicators to determine if projects are in the yellow, orange, or red census blocks indicating "disadvantaged" https://ejscreen.epa.gov/mapper/
- Think of any projects that come to mind, even beyond Urban Waters, to be considered for PDE's BIL spending
