 - i. PDE has \$90,000 for mini-grant program through 2024. Guidelines and RFP to be shared and approved at March meeting
 - ii. Other supplemental funding to leverage
 - 1. FWS native pollinator plants
 - 2. NOAA moving the money out of federal agencies is a huge challenge. One thing that could work is doing purchases
 - iii. Role
 - 1. Can help promote
 - Federal agencies need to ask if they can be on a review committee, Can send strategic priorities but might not be able to choose recipients
