- 3. Project Ideas for Delaware River Location (11:30-11:50)
 - Capacity Building at the Local Level
 - i. DCBAC is in process in doing EJ outreach around the Port of Wilmington expansion re: pollution, giving the community a voice to protect environment, housing, transportation, health, etc. Something that would be useful would be to develop a cohort of local EJ communities. Interest in developing a capacity building grant to help smaller NGOs in Wilmington.
 - ii. Funding small organizations to help them hire grant writers
 - iii. Coordinate funding between other agencies like FEMA, HUD, DEPs, as well as EPA. Help LOCAL organizations become experts in watershed issues so we can all better interact with local organizations. Have public webinars and technical assistance trainings for the communities so that they can better defend their interests and enact plans.
 - iv. Way to inform people of public meetings and funding. Perhaps the UWFP email list could help with this.
 - v. Education and mobilization about watersheds and the difference between outdoors and lead poisoning, for example

- On-the-Ground Projects
 - i. Because we are an NEP, PDE is encouraged to do on-the-ground projects. This can also be an opportunity to engage with the community, connect with legislatures, and build capacity.
 - ii. Residents in Chester and working with the 9th Street YCC / Shade Tree Commission / others
 - iii. Tacony Park in Philadelphia working with TTF
 - iv. Help capacity building by engaging the community at on-the-ground projects
 - v. Restoring fishing access to communities.
